**NOTICE OF RACE**

**1 ORGANISING AUTHORITY**

The Organising Authority (OA) will be the Storm Trysail Club in conjunction with the Farr 40 Class Association

**2 VENUE**

The venue will be Miami Beach Marina, Miami Beach, Florida, USA.

**3 PROVISIONAL PROGRAMME**

- (a) Race office open from Monday, November 26, 2007 at 1600.
- (b) Registration will be on Monday, November 26 from 1600 to 1800.
- (c) Crew weighing from Monday, November 26 from 1600 to 1800.
- (d) Skippers Briefing on Monday, November 26 at 1800.
- (e) Meeting with umpires immediately following the Skippers briefing.
- (f) Racing days are November 27 & 28.
- (g) Time of the first signal each day will be 1000 hours.
- (h) Prize giving on November 28 at 1830 hours.

**4 ENTRIES**

4.1 The skipper shall be entered on completion of registration, crew weighing and the payment of all fees and deposits. All payments shall be made by credit card, local currency or check.

4.2 Entry Fee- A non-refundable entry fee of \$US 1000 shall be submitted with the entry form or paid at registration.

**5 RULES**

5.1 The event will be governed by the rules as defined in the RRS 2005-2008, including Appendix C and Farr 40 Class Rules.

5.2 RRS 51 is modified to read: For the duration of this regatta, all moveable ballast shall be properly stowed, and water, dead weight or ballast shall not be moved, added, or removed for the purpose of changing trim or stability. Floorboards, bulkheads, doors, stairs, and water tanks shall be left in place and all cabin fixtures kept on board. The maximum amount of drinkable liquid on board each boat shall not exceed six litres per crew member per day.

5.4 Video and/or photographs taken from any source shall not be used as evidence at protest hearings. This alters RRS 63.6.

**6 BOATS AND SAILS**

The event will be sailed in Farr 40 One Design Class boats.

## **7 CREW (INCLUDING SKIPPER)**

- (a) The maximum total crew weight, determined prior to racing shall be in accordance with Farr 40 Class rules.
- (b) When a registered skipper is unable to continue in the event the Class may authorise a substitute helmsman from the original crew.
- (c) When a registered crew member is unable to continue in the event the OA may authorise a substitute, a temporary substitute or other adjustment provided that the replacement crew meets all Class Rule requirements for crew weight and classification.

## **8 EVENT FORMAT**

- (a) The event will consist of as many round robins as practical.
- (b) The Race Committee, in consultation with the Chief Umpire, may change the format, terminate or eliminate any round, when conditions do not permit the completion of the intended format.

## **9 COURSE**

- (a) The course will be windward/leeward with starboard roundings, finishing downwind.
- (b) The intended course area will be south of Government Cut to the east of Key Biscayne.

## **10 ADVERTISING**

- (a) As boats are supplied by the competitors the advertising category of the Class will apply.
- (b) Boats shall not be permitted the right to protest for breaches of any rules regarding advertising (amends RRS 60.1).

## **11 PRIZES**

Prizes shall be awarded to first through third place overall.

## **12 MEDIA, IMAGES AND SOUND**

The OA shall have the right to use any images and sound recorded during the event free of any charge.

## **13 COACH BOATS**

Coach boats shall adhere to the restrictions in the Class Rules

## **14 DISCLAIMER**

All those taking part in the event do so at their own risk. The OA, its associates and appointees accept no responsibility for any loss, damage, injury or inconvenience incurred, howsoever caused.

## **15 INVITATIONS**

Entries will only be accepted from the first eight skippers to commit.
